THE CONDITIONS OF THE ABOVE BOND ARE SUCH, That whereas, the above named principal is a dealer of motor vehicles, motorcycles, or a buyer's agent who does business by negotiating on behalf of a buyer the purchase of a motor vehicle from a motor vehicle dealer in the State of Alaska under the purview of AS 08.66 and amendments thereto, and will not commit fraud or make fraudulent representations in the course thereof. And the above bond shall remain in force unless the surety cancels, without prejudice to any liability accruing prior to cancellation, the bond in writing with the Commissioner at Division of Motor Vehicles, Attention Dealer/Fleet Manager, 1300 West Benson Boulevard Suite 300, Anchorage, Alaska 99503-3691.

If any person suffers any loss or damage by reason of fraud, fraudulent representations or violation of any of the provisions of AS 08.66, or another law of this state and amendments thereto by a dealer or buyer's agent, the person has a right of action against such dealer or buyer's agent and a personal right of action against the surety upon the bond. The aggregate liability of the surety may not exceed the amount of the bond.

NO attached documents shall modify the provisions of this bond or conditions thereto or rights of action arising under AS 08.66.
